Sterilized and Spotless

Sterilization and disinfection is one of the most critical processes in a dental practice.

Use this monthly tip to help improve your practice and keep your patients safe!

Inspection of instruments after cleaning is an important step that shouldn't be skipped.

Sterilization cycles will not destroy spores under any bioburden or materials left on instruments. The high heat can also bake on materials, making them harder to remove and possibly damage instruments.

Dental Unit Waterlines: What is your plan?

Dental Unit Waterlines (DUWLs) are often a topic of confusion in the dental practice. Waterline testing and maintenance should be regularly monitored. This month testing will be highlighted, tune in next month to learn about maintenance.

Here are some testing tips to keep your water safe:

- A test is considered passing if it is below 500 Colony Forming Units (CFUs)
- Record and trend test results and treat/ shock waterlines that are above 200 CFUs to prevent failed tests before a test fails
- Test any new waterline or waterline that has been recently shocked, if the test passes, test again in 30 days to confirm passing rates
- After the 30 day confirmation test, test all waterlines quarterly or every 90 days
- You can pool samples from the same operatory, but make sure you include water from every source in that operatory
- In office and mail-in lab tests are available, if using an in office test, ensure staff are trained to interpret results
