Sterilized and Spotless: Documentation: Load Logs

Documentation of your efforts in the sterilization area is just as important for patient safety as the technical processes that are happening.

You are using internal and external indicators on your packaging, as well as a Type V Chemical Integrator in each load, now you need to document the results. A load log (Template) can be used for this documentation and should include Sterilizer ID, Load #, Time In, Contents of Load, Time Out, Type V Test Results and Operator Initials. The CDC recommends you keep these logs for at least 3 years in case of audit.

Staff Education: Important and Ongoing

Education and training for your staff is an important and ongoing way to create an effective infection control program. This education and training should be provided to staff upon hire, annually and any time a new process or product is introduced to the facility. Records of staff training should include Name, Position, Date of Training and Topic. These training records should be kept for a minimum of 5 years, but it is recommended to keep them for the duration of employment for all employees.


Some things to think about:
