### Sterilized and Spotless: Hinged Instruments

It's important to remember that for sterilization to be successful, the steam or sterilant must come into contact with all surfaces of the device being sterilized. This can pose a challenge when processing hinged instruments.

Hinged instruments would include extraction forceps, cotton pliers, orthodontic pliers, hemostats and anything else that has a hinge and opens/ closes.

According to <u>CDC</u>, hinged instruments should remain in the open position, within their packaging for successful sterilization. If needed, there are cards and stoppers available to hold hinged instruments open in their package.


This event qualifies as infection control credit for Nebraska State Licensure and DANB CDA requirements and as an opportunity to network with others in the dental and infection control professions.
